- Patio Rental is complimentary with the purchase of a breakfast, luncheon or dinner.
- Patio events are buffet style only.
- Patio rental includes portable tents to shade the guests, a podium/microphone, prize tables, cloth tablecloths and high-quality plastic silverware and paper plates
- Ballroom rental is \$600.00 Sunday through Friday and \$1000.00 on a Saturday
- Ballroom rental includes a podium/microphone, prize tables, cloth tablecloths and napkins, china, glassware and silverware
- Additional audio-visual equipment is available with advance notice and charged at prevailing rates
- All events receive two hours of set up prior to the tournament meal and one hour of tear down time
- Our banquet staff will monitor the progress of your event during the day so that the beginning of food service coincides with the completion of golf play
- No outside food or beverages (including alcohol) are permitted on the patio or in the ballroom
- \$500.00 deposit and a signed confirmation agreement is due at the time you make your reservation. All deposits are non-refundable and non-transferable.
- Your final guarantee of attendance is due seven (7) days prior to the event. Actual charges will depend on the guarantee number or actual attendance at the event, whichever is greater.
